Procurement has a major impact on Development as resources in projects and programs are mostly used to procure goods, works or services critical to the achievement of the project development objectives (PDOs). Public procurement represents 10 to 20% of the GDP of a country. Unless the necessary control measures are in place in procurement, opportunities for fraud & corruption affect the achievement of the PDOs.

Thus, the objective of the training is to develop a shared understanding of the basic procurement principles that reinforce public procurement system; the governing procurement rules and procedures; and the tools of procurement system in Bank financed projects.
